# Early Educator Certification (EEC) The Next Step in Professionalizing the Field

Become part of the growing professional certification system. EEC is open to all NC Early Educators working directly with, working on the behalf of, or intending to work with children ages birth to twelve!

The comprehensive application may be used by all of us.... faculty, professional development providers & coordinators, teachers, consultants, trainers, assistants, Smart Start & Child Care Resource & Referral Executive Directors, staff of state early childhood agencies and programs, early childhood associations members and staff and more!

What is EEC? EEC is North Carolina's certification system for Early Educators. EEC is an acknowledgement of an individual's verified level of educational achievement, based on a standardized scale. Education is the basis for EEC. Education is coursework taken at a **regionally accredited** college or university. All public community colleges and universities in North Carolina are regionally accredited. EEC does not replace teacher licensure and is designed to complement that process.

# How much does it cost?

EEC is a self-supporting system, which has been created with funding from private and public sources with a goal of being funded primarily by individual fees when fully implemented. EEC fees are aligned with charges required by similar NC professions. The cost for an initial review is \$50. The fee for EEC recertification is \$25, if completed prior to the issued expiration date.

# How do you apply?

Complete and sign your application. Attach all official transcripts (for degrees and individual courses) to your application. Attach a check or money order Make a copy of all materials for your files.

- <u>No payment</u> will be accepted at the training event.

#### Asthma, Allergy & Anaphylaxis Training

# **Children & Youth Partnership for Dare County Training Descriptions**

#### ITS-SIDS

Learn how to provide a safe sleep environment for infants in a childcare setting. Training is required every three years and within two months of hire for staff and volunteers, and family childcare homes providers licensed to care for infants.

#### Playground Safety

Playground Safety Training addresses playground safety hazards, supervision, and general upkeep of the outdoor area. It is required for all licensed child care centers, but has very helpful and important information for family child care home providers as well.

#### **Emergency Preparedness and Response in Child Care Training**

Emergency preparedness and response (EPR) rules went into effect July 1, 2015. The rules are designed to assist licensed child care programs to be adequately prepared to respond to the needs of children and others in the event of disasters and emergencies. Participants will learn more about the rules and the required emergency preparedness and response plan.

# Hertford/Northampton Training Descriptions

# ITS-SIDS

This required training explains all the parts of the North Carolina's SIDS Law. Participants will review information about when and how to use the approved waivers, how to best place a baby in bed to sleep, and other "Best Practice" recommendations. During the workshop, participants will get the needed information to create a Safe Sleep Policy, updated research about SIDS, and local health and safety resources. Participants also will be walked through how to do an unresponsive infant drill and the reason for doing them regularly.

## **Emergency Preparedness and Response in Child Care Training**

Emergency Preparedness and Response (EPR) rules went in to effect July 1, 2015. The rules are designed to assist licensed child care programs to be adequately prepared to respond to the needs of children and others in the event of disasters and emergencies. Participants will learn more about rules and the required emergency response plan.

## **NC Foundations for Early Learning and Development**

This 5-hour course will provide participants with an introduction to Foundations, North Carolina's new Early Learning and Development expectations, how they are structured and how to implement them in early childhood settings.

# **Color Me Healthy**

Color Me Healthy is a developmentally appropriate curriculum that is highly visual and interactive. It uses color, music, dance and imaginary play to provide opportunities for physical activity and to teach children about fruits and vegetables.

## **Written Activity Plans**

North Carolina Foundations for Early Learning and Development is a single document that describes child development and learning from birth to age 5. Participants will learn how to include activities in their plans to stimulate developmental domains in accordance with NCFELDS.

## **Playground Safety**

This training addresses playground safety hazards, supervision, and general upkeep of the outdoor play area. It is required for all licensed childcare centers, but includes very helpful information for family childcare home providers as well.

## **Child Abuse and Neglect**

Participants will learn procedures for recognizing and reporting child abuse and neglect for young children. They will also learn how to identify the signs and symptoms of abuse and neglect.

## Shaken Baby Syndrome

The bodies of infants and toddlers are very fragile. Many times children are hurt without any indications or signs on the outside. Babies often die at the hands of someone close to them or providing care for them during a given period of time. Shaken Baby Syndrome training provides participants with information on how to recognize the signs/symptoms of shaken baby syndrome. They will also view first- hand the damage this can cause in the lives of our most precious treasures.

## Handwashing in Child Care

Learning how to wash your hands the right way helps to fight germs. Proper handwashing means washing away germs with running water and soap to effectively rid hands of germs. This training will provide you with tips on how good hand hygiene can protect you and the children in your child care environment.
